

## **New Residential Construction Application**

The Cuyahoga Land Bank strives to stabilize property values by removing vacant and blighted properties throughout Cuyahoga County. By removing troubled properties and returning the land to a productive use, the Cuyahoga Land Bank seeks to stem the decline in property values, prevent future foreclosures for existing property owners and beautify neighborhoods.

The Cuyahoga Land Bank welcomes individuals and for-profit organizations and companies to apply to purchase vacant land for new construction. The applicant must have a development plan that aligns with local zoning regulations and must be ready to begin development. Individuals are encouraged to work with a reputable developer/builder to ensure building requirements are met. The Cuyahoga Land Bank cannot sell vacant property for speculation or long-term land assembly.

To apply to purchase a vacant land that is owned by the Cuyahoga Land Bank, please complete the following form. Please note that additional information and supporting documents may be requested after the initial Application is received and reviewed.

## **Basic Eligibility Requirements**

Please closely review the requirements below and place your <u>initials in the boxes</u> indicating that your application meets all requirements.

The Applicant must be in substantial compliance with the local building and zoning regulations for their primary facility and/or
primary residence and other properties the Applicant owns in Cuyahoga County.
The Applicant must be current on all real estate taxes and assessments for their primary facility,
and/or primary residence must be current on real estate taxes and assessments for other properties the Applicant owns in
Cuyahoga County.
The Applicant is not a prior owner of real property in Cuyahoga County that was transferred as the result of tax
foreclosure proceedings.
The Applicant must be able to maintain the lot in accordance with all local building, housing and zoning codes.
The Applicant must develop the property in accordance with local zoning regulations.

The foregoing eligibility requirements are guidelines and may be waived or modified as determined by the Cuyahoga Land Bank to accommodate unique circumstances and funding sources used by the Cuyahoga Land Bank.
