Introduction

The Cuyahoga County Land Reutilization Corporation (Land Bank) is issuing this Request for Proposals (RFP) to contract for environmental remediation services in connection with a FY2023 Brownfield Cleanup Grant funded through a Cooperative Agreement with the United States Environmental Protection Agency (USEPA). Those interested in being considered must provide a Proposal no later than 11 a.m. on Friday, February 7, 2025.

The Land Bank and its consultant Partners Environmental (Partners) will evaluate the submitted Proposals and may choose a number to interview; final rankings will be based on the Statement of Qualifications, the Cost Proposals and any interviews. Thereafter, the Land Bank intends to enter into a contract with the finalist.

MBE/WBE contractors are encouraged to respond to this RFQ/RFP.

Project Overview

The Land Bank received funding under a USEPA FY 2023 Brownfield Cleanup Grant to remediate contamination at 12500 Euclid Ave., East Cleveland, owned by the Land Bank.

The property is a brownfield in a highly-visible part of the Circle East District, an 82-acre redevelopment area created by the Land Bank. Prior uses at the property have left a legacy of soil and groundwater contamination that is detailed in the attached Bid Specifications prepared by Partners. The US EPA funding is being used for a mix of assessment, project planning and remediation; it is expected that this contract will remediate all environmental conditions at the property.

The selected contractor will be subject to Federal contract requirements including, but not limited to, Minority Business Enterprise/Women's Business Enterprise (MBE/WBE) program, Disadvantaged Business Enterprise project certification process and minimum Federal (Davis-Bacon) wage rates, where applicable.

Scope of Service

Please see the attached Bid Specifications prepared by Partners Environmental.

Submission Procedures

Responses should be emailed to demobids@cuyahogalandbank.org, where they will be sequestered until 11 a.m. on February 7. Responses should include:

(1) Statement of Qualifications (SOQ) providing reviewers with information about the contractor's relevant experience and abilities to conduct the remediation activities detailed in the Bid Specifications. Beyond any required minimum qualifications, the primary criteria for evaluation are:

I. Identification and Background Information

- 1. Contractor's name, business postal address, contact name, telephone and fax numbers, email address
- 2. Federal I.D. number
- 3. Ohio Tax I.D. number
- 4. The entity's legal form (e.g., corporation, sole proprietor, etc.) and State of incorporation, date of formation, name changes and mergers
- 5. Relevant brochure and promotional materials.

II. Qualifications and Experience

- 1. Provide a concise history of the contractor, its main partners/officers and largest shareholder(s).
- 2. Provide a description of up to five remediation projects managed by the contractor in the prior three years. Include project dates, project titles, location, key employees involved, and originally-estimated and final costs.
- 3. Describe your firm's experience with managing relevant remediation projects.
- 4. Include a description of your firm's resources, including staff, equipment and capital available for project use and deployment. Explain approaches used to control costs on previous projects.
- 5. Provide any additional information that would support selection.

III. Personnel

Identify and describe the functions of key personnel that will be assigned to lead the project's remediation work. Project requirements may not be satisfied by subcontracting or partnering. Include such information as personnel name and title.

IV. References

Include three clients for whom the candidate has provided brownfield remediation in the past three years. Provide the name, telephone number, and e-mail address of a contact for each client and a brief description of the work completed.

V. Required Attachments

- 1. Workforce composition form (EEO-1) unless exempt
- 2. Contribution Disclosure Form (see Attachment A)
- 3. Non-Collusion Affidavit (see Attachment B)
- 4. Debarment and Suspension Certification (see Attachment C)
- 5. Upon selection only, the following will be required:
 - a. Current certificate of professional liability, malpractice, and errors and omissions insurance (must name Land Bank as additional insured).
 - b. Current certificate of general liability insurance
 - c. Workers Compensation Certificate
